CLUB RULES

GENERAL RULES

- 1) Members shall be entitled to participate in competitions and events organised by the club. Failure to produce their membership card if requested by a competition steward may result in disqualification.
- 2) New members (a person who has not belonged to the club for at least two years including the current year) who join the club from November 1st and upon payment of the membership fee will be given the following years membership free.
 - 2b) Anybody who is not already a member of the club and who joins after the AGM. Will be classed as a member for the remainder of December of that year as well as having a full year's membership the following year.
 - 2c) Members have until 14th January each year to renew their membership. If membership is not renewed by this date your membership will lapse. (If your membership lapses any Club Record Fish, Specimens or points earned in Species League will become void).
- 3) The club does not and will not hold itself in any way responsible for accidents, personal injury (whether fatal or otherwise) loss of property, income, or consequential loss, to members or guests whilst engaged in club activities.
 - 3a) Members must not fish areas where there is no public access i.e. Portland Harbour and the apron on the Jurassic Pier where there is a sign that says no access.
 - 3b) Members and guests whilst engaged in club matches and activities must abide by all warning signs permanent or temporary. If members or guests do not, the club will not be held liable for any loss or injury.
 - 3c) It is the responsibility of club members to check any local byelaws for the area they are fishing.
 - 3 d) Members must not overhead cast on any of the piers at West Bay.
- 4) The winner of a challenge trophy will give a satisfactory guarantee to the committee as to its safe custody and return.
- 5) Competitors who tie for any trophy will hold it for an equal period, certificates will be awarded.
- 6) The decision of the committee on the award or otherwise of prizes and trophies will be final.
- 7) When pleasure fishing, no more than two rods with up to three hooks between them, or two pannel mounted baits, one on each rod at any one time, so constructed that the measurement between the eyes of the two hooks does not exceed 10cm for shore and 20cm boat; a treble hook counts as one hook but no more than one treble hook and two single hooks may be used in a rig, with the exception of plug type spinning lures which are permissible when used alone.
- 8) The committee reserve the right to amend, add to, or cancel any rules, match dates, times, social dates, sizes, specimen weights etc. as circumstances arise.
- 9) All fish entered for specimen honours i.e. Angling Trust medals and or club trophies or records, must be weighed on certified scales.
 - 9a) Weighing of Fish: the first set of certified scales a fish is weighed on is the weight that is to be used.
 - 9b) Any fish that is sold, bartered or traded, can not be entered for club, national or divisional awards or honours.
- 10) Crustaceans, squid, octopus, cuttlefish, salmon, sea trout and protected species i.e. shad, are ineligible.
- 11) Club waters are defined as:
 - 11a) Shore: Angling Trust area D, Hants/Dorset border to the river Exe.

11b) Boat: within lines drawn due south from Portland Bill and Beer Head with no offshore limit.

11c) Boat record claims: boats fishing within club water limits may present their catch for club records regardless of point of departure or return.

12) Invited guests are permitted to take part in up to two club matches per annum (with the exception of the Christmas Fayre and the Specimen & Species Festival which is restricted to members only).

12a) Guests are not permitted to win club trophies.

13) Junior membership for the current year is defined as being under the age of 17 years old on the 1st of January.

15) All challenge trophies are to be returned to the cup custodian at least 28 days prior to the annual dinner/dance presentation evening, cleaned and in good order.

16) Members who suffer from a disability may receive such minimum assistance as required to cast, play or land a fish. Use of electrically assisted reels by disabled members is permitted.

17) For club honours/records & specimen claims, fish can be weighed & witnessed at sea on certified scales. Sharks and tope must also have measurements of length and girth taken and a photograph for proof. The fish must then be released (please note tope must not be brought back from a boat or shore dead or alive, but must be put back alive as they are now catch and release only, by law).

18) Any member wishing to fish club competitions from charter boats must make their own arrangements with the skippers concerned.

19) West Bay Sea Angling Club abides by the Angling Development Board Child Protection Document (available upon request from the club secretary).

20) Shore definition: fishing from any land mass or fixed man-made structure.

GENERAL COMPETITION RULES

(This section will only have general competition rules for both shore and boat; more specific rules will be found under their own section)

1) Entrance fees shall be paid to the match steward or any other committee member. If none are available, and you arrive late, another member must be advised that you are competing prior to commencing to fish. Payment to be paid at the end of the match.

2) All club closed competitions will be fished to W.B.S.A.C rules.

2a) Shore matches: the entry fee for the current year will be stated on the match fixtures list.

2b) Boat matches: the entry fee for the current year will be stated on the match fixtures list.

2c) Saturday juniors: the entry fee for the current year will be stated on the match fixtures list.

3) Competitors in shore and boat matches may use no more than two rods with up to three hooks between them or two pennel mounted baits, one on each rod at any one time, so constructed that the measurement between the eyes of the two hooks does not exceed 10cm for shore or 20cm for boat. A treble hook counts as one hook but no more than one treble hook and two single hooks may be used in a rig, with the exception of plug type spinning lures which are permissible when used alone.

3a) No angler may use 2 hooks or more on the same rig using the sink and draw method either using lures or baited hooks (no feathering) in shore matches.

4) Hand lines or casting other than with a rod are forbidden.

5) The competitor must cast the line and land the fish. However, assistance may be received by means of a gaff or net and unhooking the fish; junior members may receive assistance in casting at the discretion of the steward.

6) Shore match competitors must bring their own fish to the scales. In all shore and boat competitions no fish shall be weighed in of less size and weight than that shown in the club schedule of minimum sizes.

6a) Shore match: competitors may only bring six fish of each species to the scales for

weighing in.

6b) Boat match: competitors can only bring two of each species to the scales for weighing in.

6c) Foul hooked fish: fish hooked in front of gill opening to be allowed to be weighed in, in club closed competitions and for all awards. The no foul hooked rule still applies in open competitions and for British record claims.

6d) Weigh and release of fish: in club matches fish caught may be weighed on certified scales and witnessed by a fellow competitor (photographed if possible) then released. These will still count for the match and club honours.

7) No catch shall be accepted for weighing in after 30 minutes from the advertised time the competition ends. Boats not between the piers before the specified time may be disqualified.

8) Any objection can not be entered into once the scales are closed, either by reaching the allotted time or by being closed by the match steward once all competitors have weighed in.

9) Shore and boat matches: Please see individual competition rules for how match results will be decided.

10) A shore competition cannot take place unless a minimum of three members are present. A boat competition cannot take place unless a minimum of three members are present with the exception of the Hilda Pettet memorial trophy and boat competition where no minimum number applies.

11) Any competitor bringing undersized fish to the weigh-in may have the weight of those fish deducted from the total weight of their catch.

12) Any competitor not adhering to these rules may be disqualified.

13) Should a boat cup competition be cancelled the award will be held over to the next available monthly boat match.

14) Registration for all shore matches will not be accepted more than one hour before the start of the competition.

14a) Registration for shore matches will close 15 minutes prior to the scheduled start time of the match.

15) During club matches a facility shall be made for senior citizens and disabled anglers at the match venue where possible; where no facilities are available, they may fish at a mutual place to be decided on the match day. The weigh-in will be at the normal match venue.

SHORE MATCH RULES FOR SUNDAY DAYTIME AND THURSDAY NIGHTS

Dates and times of matches and entry fees as on the current Match Fixtures List.

Sign on at the venue, entrance fees shall be paid to the match steward; if you arrive late another member must be advised that you are competing prior to commencing to fish. Match fee to be paid at the end of the match.

The prizes shall be paid out as follows:

1st Prize: heaviest bag - 50% of entry fee.

2nd Prize: heaviest bag - 30% of entry fee.

3rd Prize: heaviest bag - 20% of entry fee.

Most species: 100% of optional pool.

Heaviest fish: 100% of optional pool.

The points allocated towards end of year trophies will be: winner 5, second 4, third 3; all other weighing in 2, all other who entered 1; an extra point will be awarded to the angler taking the pool.

RULES

1) There must be at least three competitors for the match to be valid.

2) The match may be cancelled due to bad weather; in the event of bad weather, please ring the phone number on the current Match Fixtures List.

3) Competitors may use no more than two rods with up to three hooks or two pannel mounted baits, one on each rod at any one time, so constructed that the measurement between the eyes of the two

hooks does not exceed 10cm. A treble hook counts as one hook but no more than one treble hook and two single hooks may be used in a rig, with the exception of plug type spinning lures which are permissible when used alone.

- 3a) No angler may use 2 hooks or more on the same rig using the sink and draw method, either using lures or baited hooks (no feathering).
- 4) Only six of each species to be brought to scales. No catch shall be accepted for weighing in after 30 minutes from the advertised time the competition ends.
- 5) Any competitor bringing undersized fish to the weigh-in may have the weight of those fish deducted from the total weight of their catch.
- 6) Fish may be weighed and released during the match in the presence of a witness and returned. Scales used must be certified.
- 7) Any objection can not be entered into once the scales are closed, either by reaching the allotted time or by being closed by the match steward once all competitors have weighed in.

WALLY PETTET MATCH RULES

The Wally Pettet Match is fished to the same rules as the Sunday daytime matches except that this is a two day match over a Saturday and Sunday. Competitors may fish both of the days or either of the two days. Members must sign on at the venue each day not earlier than one hour before start of match. Entry fee as stated on current Match Fixtures List and covers both days of the match.

ANDY NEAL ROVERS MATCH RULES

Match dates as stated on the current Match Fixtures List. Sign on at the ANGLING CENTRE WEST BAY from 4:30pm, match starts at 5:00pm, ends 11:00pm. Please note: if you arrive after the match steward has left you can still join the match up to the Angling Centre closing time, tell a member of staff you intend to fish the match, then phone Fish Recorder or the Club contact number (phone numbers will be on your membership card and match fixtures list). If not answered, leave a message, as this will be checked before the match has finished. Members can also enter the match by meeting up with a committee member. Late starters to pay at the end of the match. The reason for needing to phone is for safety reasons; we need to know who is fishing to enable the match steward to account for all participants.

Match fee is as stated on the current Match Fixtures List.

Prize structure:

- 1st Prize: heaviest bag - 26.66% of entry fee.
- 2nd Prize: heaviest bag - 20.02% of entry fee.
- 3rd Prize: heaviest bag - 13.33% of entry fee.
- 4th Prize: most species - 26.66% of entry fee. (This is equal to first prize in money value).
- 5th Prize: heaviest fish - 13.33% of entry fee (heaviest fish with the above bags removed).

Tiebreak for most species will be the heaviest bag, but not the winning heaviest bag; same for the heaviest fish but not including the removed 4 bags, if 1st, 2nd or 3rd heaviest bags are tied, then tied bags will be added together and the prize money will be split evenly between those tied.

RULES

1) Competitors may use no more than two rods with up to three hooks or two pennel mounted baits, one on each rod at any one time, so constructed that the measurement between the eyes of the two hooks does not exceed 10cm. A treble hook counts as one hook but no more than one treble hook and two single hooks may be used in a rig, with the exception of plug type spinning lures which are permissible when used alone.

- 1a) No angler may use 2 hooks or more on the same rig using the sink and draw method either using lures or baited hooks (no feathering).
- 2) Only six of each species to be brought to the scales.
- 3) Competitors must bring their own fish to the scales.

- 4) No catch shall be accepted for weighing-in after 30 minutes from the advertised time the competition ends.
- 5) Any competitor bringing undersized fish to the weigh-in may have the weight of those fish deducted from the total weight of their catch.
- 6) Any objection can not be entered into once the scales are closed, either by reaching the allotted time or by being closed by the match steward once all competitors have weighed in.

It is unlikely a rover match will be cancelled or postponed. However, if weather conditions are extreme, storm force winds forecast or heavy snow, please check with the Angling Centre (01308 421800) before travelling.

SAFETY RULES FOR ANDY NEAL ROVER MATCHES

In the interest of safety, members who participate in Andy Neal Rover matches are to return to the weigh-in to be checked in. However, if a participating member wishes to leave the match early, they must first inform another competitor who is returning to the weigh-in. Another option is to contact the Fish Recorder or club contact number (phone numbers will be on your membership card and match fixtures list). If not answered leave a message, as both phones will be checked before the match ends. The above is to ensure the match steward is aware of those who have left the match and if any members are missing.

PLEASE NOTE: FAILURE TO COMPLY WITH THE ABOVE RULE COULD MEAN CALLING OUT THE COASTGUARD TO SEARCH FOR ANY MISSING MEMBERS.

SATURDAY JUNIOR AND JURASSIC LEAGUE MATCH RULES

Entry fee as stated on current Match Fixtures List. Sign-on East Pier from 11.50am.
The points allocated towards end of year trophies will be: winner 5, second 4, third 3; all others weighing in 2, all others who entered 1 (these only count towards the Saturday Junior Matches as the Jurassic League winner is by heaviest aggregate weight).

RULES

- 1) Maximum one rod and three hooks only.
- 2) Assistance with casting is at the discretion of the steward.
- 3) No feathering.
- 4) You must weigh in your own fish which must be done BEFORE re-baiting and/or re-casting.
- 5) All fish not being kept to be put back carefully after weighing.
- 6) Any fish being kept for eating or bait to be of legal size and dispatched quickly.
- 7) Total weight of legal sized fish to take precedence over total weight of undersized fish.
- 8) All litter to be picked up and placed in nearest bin.
- 9) Please be civil to other competitors and members of the public.
- 10) Members must remember to register their own specimen/notable fish with the fish recorder.
- 11) No inappropriate behavior i.e. horseplay by adults or children.
- 12) The match steward's decision is final.

BOAT MATCH RULES

Dates and times of matches and entry fee as on the current Match Fixtures List.
Steward will collect entry fee and issue match card from the boats taking part.
Prize Structure: all prizes are of equal value.

- 1st Prize: heaviest bag with a maximum of two of each species.
- 2nd Prize: most species, with the above bag removed.
- 3rd Prize: best fish, with the above two bags removed

RULES

- 1) There must be at least three competitors for the match to be valid with the exception of the Hilda Pettet memorial trophy and small boat competition where no minimum number applies.
- 2) Limits: within lines drawn due south from Portland Bill and Beer Head with no offshore limit.
- 3) Competitors may use no more than two rods with up to three hooks or two pennel mounted baits, one on each rod at any one time, so constructed that the measurement between the eyes of the two hooks does not exceed 20cm. A treble hook counts as one hook but no more than one treble hook and two single hooks may be used in a rig, with the exception of plug type spinning lures which are permissible when used alone.
- 5) Matches are fished either for designated trophies or simply as a match. In the event of bad weather causing a trophy match to be cancelled it will be rolled over to the next available match.
- 6) Fish may be weighed at sea in the presence of a witness and returned. Scales used must be certified.
- 7) Only two of each species to be brought to the scales.
- 8) Any objection can not be entered into once the scales are closed, either by reaching the allotted time or by being closed by the match steward once all competitors have weighed in.

West Bay Sea Angling Club Species League

(annually from 1st January to 31st December)

RULES

Please note there is no entry fee.

Members earn points when participating in any WBSAC senior closed shore and boat match (no open matches). Please note shore and boat end of year bonus point records are kept separately.

Minimum numbers fishing per match to be as per club rule 12.

To qualify for the opportunity of becoming the Species League Champion, members must fish within the club year a minimum of 10 matches. Once achieved the aim is to keep bettering one's own lowest score, to earn as many points as possible, and also build up end of year bonus points, as match points and bonus points added together will determine the Species League Champion (there will also be a match points champion and a handicap league based on match points earned).

MATCH POINTS

1 point: no fish brought to the scales.

2 points: for weighing in.

HEAVIEST FISH

3 points for the heaviest fish.

2 points for the second heaviest.

These two fish removed:

1 point for the heaviest of each species.

No individual member can have 1st and 2nd heaviest fish, in this instance the points move to the 3rd heaviest fish, and the 2nd heaviest earns 1 point as the heaviest of its species. In the event of any tie all tied members receive the same number of points.

Species Caught in match:

Shore 3 = 1 point, 4 = 2, 5 = 3, 6 = 4, and so on.

Boat 5 = 1 point, 6 = 2, 7 = 3, 8 = 4, and so on.

END OF YEAR BONUS POINTS

Heaviest fish of the year from shore will receive 5 bonus points and the heaviest fish of the year from boat will also receive 5 bonus points. No member can receive both. E.g. a member has caught the heaviest fish from boat, a conger of 15 kg, and from shore a cod 7 kg; the conger earns 5 bonus points.

With these two fish removed: 3 points for the heaviest of each species, 2 points second heaviest, and 1 point third heaviest. This applies to both shore and boat; no member can have 1st, 2nd and 3rd heaviest

of any species. Only the best fish caught per member will earn bonus points.
In the event of any tie all tied members receive the same number of points.

If a member competes in both shore and boat matches that member's best result will count, not both.
e.g. 17 heaviest of each species points earned from boat and 15 earned from shore = 17 bonus points awarded.

Please note: (boat only) heaviest of each species and league records stand from 2009 whether or not the member has qualified; this is due to matches being cancelled and preventing members who fish boat matches only qualifying, giving those who fish boat and shore a possible unfair advantage.

Species points: all members earn 1 point for each species caught in shore matches and 1 point for each species caught in boat matches. e.g. a member catching 15 species during the year will earn 15 bonus points. If any member competes in shore and boat matches, the members' best result will count, not both e.g. if 8 species were caught from the boat, and 9 species from the shore, 9 bonus points would be earned.

Should more than one member have the same total number of points at year-end, the tied member who has caught the best specimen from closed matches will determine ties; this applies for all awards. The junior champion will be the junior who earns the most points fishing senior matches providing that the junior has qualified i.e. has fished 10 senior matches minimum.

SPECIES LEAGUE CHAMPIONSHIP AWARDS

1st £50-00, framed certificate and an inscribed cap.

2nd £30-00.

3rd £20-00.

4th £15-00.

5th £10-00.

Match Points Champion: framed certificate.

Top Lady: framed certificate.

Top Junior: framed certificate.

Handicap League (prizes are Angling Centre vouchers)

1st £30-00 voucher and a framed certificate.

2nd £25-00 voucher.

3rd £20-00 voucher.

4th £15-00 voucher.

5th £10-00 voucher.

Please note handicaps are issued in January of each year.

Angling Trust minimum sizes will apply to all fish brought to the scales, except mackerel 35cm (boat only)

A separate junior match Species League Championship will be run along side the senior league, with a 1st 2nd and 3rd certificate, plus a Junior League Match Points Champion certificate. For the juniors league the fish ten matches to qualify rule is dropped; minimum size does not apply as all fish are returned.

THE CONSTITUTIONAL RULES OF THE WEST BAY SEA ANGLING CLUB

As approved at the Extraordinary General Meeting 2010 and effective thereafter

WEST BAY SEA ANGLING CLUB

Affiliated to Angling Trust and Wyvern Division A.T.

- 1) The club shall be known as: 'The West Bay Sea Angling Club'.
- 2) The club's headquarters shall for the current year be as stated on the match fixtures list.
- 3) The object of the club is to promote the sport of sea angling in all its forms using rod, reel and line, by competitions or any other method that may seem desirable, with equal opportunities for all.
- 4) The club shall consist of:
 - Honorary life members
 - Full adult members
 - Senior citizen members
 - Junior members

Both the senior citizen and junior members to receive special subscription rates.

- 5) To become a member of the club, a person must:

Senior members: be 17 years of age or over on the 1st January of the current year having paid his/her annual subscription.

Junior members: be under the age of 17 years on the 1st January of the current year having paid his/her annual subscription.

Senior citizen members: be over the age of 60 years on the 1st January of the current year having paid his/her annual subscription.

Honorary life member: to be voted as such at an annual general meeting (**note: Honorary life members are not required to pay subscriptions**).

- 6) There shall be appointed a general committee who will be charged with the management of the affairs of the club in all matters not reserved for the annual general meeting. The general committee shall be appointed annually at the annual general meeting. The general officers of the committee shall consist of:

President	Vice president/s
Chairman	Vice chairman
Secretary	Treasurer
Boat secretary	Shore secretary
Fish recorder	Junior secretary
Press officer	

Should it be deemed prudent one individual may hold more than one post.

In addition to the above officers there shall be appointed up to a further six committee members. All of the above elected committee members shall have full voting rights at committee meetings, five to form a quorum.

6a) The general committee shall have the power to co-opt up to three persons who may or may not be members of the club. Such co-opted members will not have voting rights at a committee meeting.

6b) The general committee shall appoint such members to form subcommittees as it deems necessary. Such sub committees to have no authority to amend rules etc. without prior reference to the general committee.

6c) Should a vacancy arise on the general committee, the committee shall have the power to fill same and the member appointed will hold office until the next annual general meeting. Such co-opted members will not have voting rights at a committee meeting.

6d) No person may serve on the general committee until they have been a club member for at least twelve consecutive months.

6e) Any member of the club may propose any other club member (other than junior members)

to serve on the general committee, subject to rule 6d, provided that the nominee is willing to serve and that the proposal is seconded and received before the start of the AGM. Persons already serving as officers or committee members who wish to carry on their duties for a further year and who are unopposed will be deemed 'elected unopposed' making a ballot unnecessary.

6f) The committee shall meet once a month at the club's headquarters. The date and time will be on the match fixtures list.

6g) Any committee member being absent from three consecutive monthly meetings without giving a satisfactory reason, may cease to be in office.

7) The club's financial year shall end on the 31st December annually.

8) All cheques and promissory bonds to be signed on the club's behalf by two authorised signatories.

9) The annual general meeting will be held at the club's headquarters in the month of December.

9a) At the annual general meeting the treasurer will ensure that a factual statement relating to the club's financial affairs has been prepared and approved by an appointed auditor. Such auditor to be appointed annually by the general committee.

9b) At the annual general meeting the voting will be confined to members of the club (excluding junior members) each voting member to have one vote.

9c) All proposals (except those recorded under rule 10) whether recorded at an annual general meeting, extraordinary or committee meeting shall have a proposer and seconder and be accepted on the basis of a majority vote. The chairman in the event of equal voting shall have a further casting vote.

9d) Proposals for inclusion at an annual general meeting or any extraordinary general meeting must be in the hands of the secretary at least twenty one days prior to said meeting except those covered under rule 6e. No other business shall be conducted at such meetings other than as recorded on the agenda.

10) The constitutional rules of the club may be revoked, added to or altered by a majority of two thirds or more of the members present and voting at an annual general meeting or extraordinary general meeting subject to the proviso that such proposed amendments are notified in writing to the secretary at least twenty one days in advance of the meeting.

11) An extraordinary general meeting may be summoned at any time on given notice of twenty ones days by either:

The general committee.

A requisition to the secretary signed by at least ten full members of the club.

12) The annual membership subscription/s shall be fixed annually by the general committee having taken into account the current financial position of the club.

13) No complaint will be considered unless received in writing to the secretary.

13a) Members of the club whose conduct is inappropriate or who decline to abide by any rules or bylaws may be expelled or suspended by a resolution passed at a committee meeting where their entrance fee and subscriptions may be forfeited. Members shall have the right to appeal in person to the committee with regard any decision affecting themselves, provided that notice of such appeal be submitted to the secretary, in writing, within seven days of notification of the decision.

14) Bursary Scheme: the club shall make available a bursary of £50, for any member who meets the criteria set out below.

14a) The member has been chosen for one of the Angling Trust's national squads, these squads will be: England ladies, England men's, England juniors and England youth, in casting, shore or boat fishing.

14b) The member must have paid their club dues for the current year.

14c) The member must have been a member for at least two full consecutive club years (January - December).

14d) The member must attend a committee meeting to request the payment of the bursary and bring with them proof of selection (the member must notify the secretary one week before the meeting they wish to attend).

The bursary will only be available once per member. The club has the right to withdraw the offer of a bursary if they feel there are insufficient funds available within the clubs finances to meet this.

15) Dissolution

15a) If at any committee meeting of the club, a resolution be passed calling for the dissolution of the club, the secretary shall immediately convene an extraordinary general meeting of the club to be held not less than one month thereafter to discuss and vote on the resolution.

15b) If at the extraordinary general meeting, the resolution is carried by at least two-thirds of the full members present at the meeting, the committee shall thereupon, or at such a date as shall have been specified in the resolution, proceed to realise the assets of the club and discharge all debts and liabilities of the club.

15c) After discharging all debts and liabilities of the club, the remaining assets shall not be paid or distributed amongst the full members of the club but shall be given or transferred to some other voluntary organisation having objects similar to those of the club.

WBSAC CUPS & TROPHIES.

Any future trophies that members or non-members wish to present to the club must first pass through the committee for approval.

(All cups and trophies are for inside club waters unless otherwise stated)

SHORE
